

Minutes of Regular Meeting  
Iola Texas Board of Alderman  
June 10, 2025

The Board of Alderman of the City of Iola, Grimes County, Texas, met in regular session at 7:00 p.m. at the Iola Community Center Building in Iola TX. Members present: Mayor Christina Stover, presiding, Alderman present: Becky Evans, Benjamin Landry, Wayne Cadro, Gail Black.

The meeting was called to order at 7:00 p.m.

New Business was conducted:

The executed Statement of Officer for the two re-elected Alderman-Benjamin Landry and Wayne Cadro and the newly assigned Alderman Gail Black was submitted to the City Secretary for filing. The Mayor presented the Oath of Office to Alderpersons Wayne Cadro, Benjamin Landry, and Gail Black.

Minutes for the regular meeting held May 13, 2025 were read for approval. Motion to approve by Gail Black, seconded by Ben Landry. Motion carries unanimously.

Becky Evans made a motion to Proclaim April as Fair Housing Month second Ben Landry. Motion carries unanimously

Gail Black moved to approve a Resolution to designate authorized signatories for the Community Development Block Grant - Mitigation program (CDBG-MIT) for GLO state contract number 24-065-165-F080, second was made by Curtis Darby; motion carried unanimously. Ben Landry second the motion. Motion carries unanimously.

Gail Black moved to approve a resolution regarding Civil Rights which includes the following policies: Citizen Participation Plan and Grievance Procedures; Section 3 Policy; Excessive Force Policy; Limited English Proficiency (LEP) Standards Plan; o Section 504 Policy and Grievance Procedures; • Code of Conduct Policy; and • Fair Housing Policy. Second by Wayne Cadro, motion carried unanimously.

Ben Landry made a motion to pay an invoice for an amount greater than 250.00 to City Attorney's Bovey and Cochran. Second Becky Evans. Motion carries unanimously.

The discussion and preliminary review of the FY 2025-2026 budget did not require action.

Becky Evans made a motion to approve the chip seal of Fort Worth St and Bulldog Lane requested by the GC Road and Bridge Dept. Gail Black second the motion. Motion carries unanimously.

The Mayor updated the council on the WWTP.

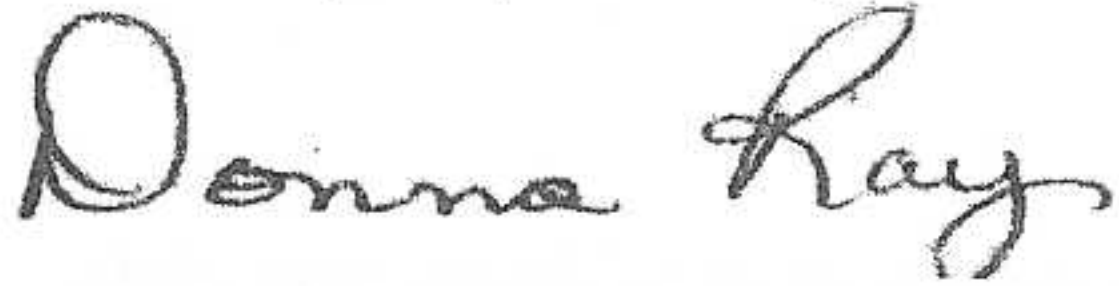
